

Chronological Recount Paragraph

Yesterday afternoon, the Roman Army led by Emperor Claudius arrived on the shores on Britain around 3.00pm for approximately an hour before they moved inland to begin to set up camp. This is supported by an eyewitness (a local fisherperson) who was out catching fish for his people who live close by at around 2:30pm. Therefore, the evidence suggests that the Roman Army entered Britain between 2:30pm and 3:00pm. When the Romans arrived in Britain, they began to set up tents and finding food for their soldiers. Reports indicate that the Romans have not begun conquering nearby villages. However, is it thought that the Romans are here to take over Britain.

What is the purpose of the chronological recount paragraph?

- Provides detailed information about the event.
- Recounts events in chronological order.
- Helps the reader understand exactly what happened.




